8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH. Day**
9 **of JANUARY, 2010 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0-**
10 **AGAINST; -0- NOT VOTING; and 198.70[07] ABSENT, pursuant to the powers vested in the Council**
11 **by Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham**
12 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
13 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
14 **of the Act of June 18, 1934 (48 Stat. 984).**
