12	WHEREAS,	on June 15, 2009, the Department of the Interior approved the Revenue Allocation
13		Plan; and
14	WHEREAS,	in accordance with the Revenue Allocation Plan, the Tohono O'odham Membership
15		Services presented the Master List for eligible Tohono O'odham Minor Members for
16		the Fourth Per Capita Distribution and established the number of eligible minor
17		members at 8,664 members pursuant to Resolution #09-429; and
