

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Carry Forward of Unexpended Funds of KOHN 91.9 FM's Corporation for Public Broadcasting Community Service Grant in the Amount of \$ 37,287.44 into FY 2010 and Approving Budget Amendment # 1 of KOHN's Corporation for Public Broadcasting Community Service Grant FY 2010 Budget increasing the budget from \$187,539.99 to \$ 224,827.43; Authorizing Expenditures)

RESOLUTION NO. 10-011

1 **WHEREAS, Corporation for Public Broadcasting grant funds (grant funds) remain unexpended**
2 **at the close of fiscal year 2009 in the amount of \$37,287.44 as presented in the attached**
3 **Budget Amendment #1 (amendment #1), incorporated into this resolution by this**
4 **reference; and**

5 **WHEREAS, Corporation for Public Broadcasting permits a two year period in which to expend**
6 **grant funds as awarded and accepted; and**

7 **WHEREAS, the two year Corporation for Public Broadcasting spending authority for grant funds**
8 **awarded in fiscal year 2009 will not expire until September 30, 2010; and**

9 **WHEREAS, KOHN 91.9 FM has prepared a carry forward budget, attached as Amendment #1**
10 **adding the unexpended grant funds of \$37,287.44 to the current KOHN Corporation for**
11 **Public Broadcasting Community Service Grant (CPB CSG) FY 2010 budget, increasing**
12 **the budget from \$187,539.99 to \$224,827.43 and has submitted the carry forward**
13 **budget for review by the Executive Office, Cultural Preservation Committee and the**
14 **Budget & Finance Committee; and**

15 **WHEREAS, the amendment # 1 provides for the elimination and transfer of an On-air Announcer**
16 **position normally funded through these carry forward dollars under the CPB Grant**
17 **for which a separate budget amendment for KOHN's administrative budget has been**
18 **prepared to place this position under the KOHN Administrative Budget funded**
19 **through the Nation's general fund.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
21 **approve the carry forward into fiscal year 2010 of unexpended funds in the amount**
22 **\$37,287.44 approving budget amendment #1 of KOHN's Corporation for Public**
23 **Broadcasting Community Service Grant FY 2010 budget to incorporate the carry**
24 **forward, attached as Amendment #1, incorporated into this resolution by this**
25 **reference, increasing the budget from \$187,539.99 to \$224,827.43.**

26 **BE IT FURTHER RESOLVED that the amendment # 1 provides for the elimination and transfer of**
27 **an On-air Announcer position normally funded through these carry forward dollars**
28 **under the Corporation for Public Broadcasting Grant for which a separate budget**
29 **amendment for KOHN's administrative budget has been prepared to place this**

4 **Corporation for Public Broadcasting Community Service Grant funds in accordance**
5 **with the attached budget for the remaining term of Corporation for Public**
6 **Broadcasting's spending authorization, retroactive to October 1, 2009 through**
7 **September 30, 2010.**

8 **BE IT FINALLY RESOLVED that the Nation's officials to-wit the Chairman or any other designated**
9 **official are hereby authorized to execute any agreement necessary to expend the grant**
10 **funds provided that any amendments affecting the grant funds or funding level shall**
11 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**
13 **of JANUARY, 2010 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0-**
14 **AGAINST; -01- NOT VOTING; and 198.70 [07] ABSENT, pursuant to the powers vested in the Council**
15 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
16 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
18 **18, 1934 (48 Stat. 984).**
