

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving and Authorizing Amendment #1 of KOHN 91.9 FM's FY 2010 Budget)**

**RESOLUTION NO. 10-012**

1 **WHEREAS, KOHN has one On-Air position (position) which is funded through available carry**  
2 **forward funds, the balance of unexpended funds from the previous fiscal year of the**  
3 **Corporation for Public Broadcasting Community Services Grant (CPB CSG); and**

4 **WHEREAS, Due to the uncertainty of continued funding levels from CPB CSG, it is in the best**  
5 **interest of KOHN to transfer this position to the KOHN general fund budget, effective**  
6 **October 1, 2009 to assure secured funding for this position; and**

7 **WHEREAS, KOHN management has prepared and presented the attached amendment #1 of its FY**  
8 **2010 budget, incorporated into this resolution by this reference, to provide for the**  
9 **transfer of this position to the KOHN general fund budget; and**

10 **WHEREAS, the amendment re-allocates \$34,004.42 from operational funds towards the annual**  
11 **salary and employee benefits of the position; and**

12 **WHEREAS, KOHN management has presented the attached amendment #1 of its FY 2010 budget**  
13 **to the Executive Office and appropriate oversight committees.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
15 **approves and authorizes amendment #1 of KOHN 91.9 FM's FY 2010 budget to be**  
16 **expended as attached.**

17 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it approves the**  
18 **transfer of one On-air Announcer position from the Corporation for Public**  
19 **Broadcasting Community Services Grant effective October 1, 2009, to the general fund**  
20 **KOHN administration budget.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation's Officials to-wit: the Chairman, and any designated official, are authorized to**  
23 **execute the budget amendment, provided however, that any amendments affecting**  
24 **the funds or funding levels of the budget shall be submitted for further prior approval**  
25 **by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day**  
27 **of JANUARY, 2010 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and 198.70 [07]ABSENT, pursuant to the powers vested in the Council**  
29 **by Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted**  
30 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat. 984).**




