

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Ali Chugk Community Plane Settlement Budget in the amount  
of \$17,681.40 for FY' 2010)**

**RESOLUTION NO. 10-013**

1 **WHEREAS, the Gu-Vo District Governing Council did meet at regular scheduled Council Meeting**  
2 **held on the 15th of December 2009 to approve the Ali Chugk Community's Budget to**  
3 **utilize the Plane Settlement Funds in the amount of \$17,681.40 for FY' 2010; and**

4 **WHEREAS, the Gu-Vo District Governing did approve for equal distribution on the Plane**  
5 **Settlement by Resolution GV09-130 at \$17,681.40 for the Administration, and Gu-Vo,**  
6 **Ali Chugk, Pia-Oik and Kukatch Community; and**

7 **WHEREAS, the Ali Chugk Community has approved to use their equal portion of the Plane**  
8 **Settlement to provide payment for the remainder owed to Mobil Mini in the amount**  
9 **of \$17,681.40; and**

10 **WHEREAS, the Ali Chugk Community did present to its membership the budget of \$17,681.40 FY'**  
11 **2010 for review and approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
13 **approve the Ali Chugk Community FY' 2010 Plane Settlement Budget in the amount of**  
14 **\$17,681.40.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Chairperson and any designated official to expend and administer the budget as**  
17 **attached, provided that any amendments affecting the funds or funding level shall be**  
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day**  
20 **of JANUARY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section**  
22 **1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**




