RESOLUTION NO. 10-015

1 **WHEREAS, the Tohono O'odham Nation and the Tohono O'odham Legislative Council support the**
2 **Districts in their efforts to improve quality of life for their communities and members;**
3 **and**

4 **WHEREAS, efforts to improve quality of life in any one District are beneficial for the Nation as a**
5 **whole; and**

6 **WHEREAS, the National Park Service offers funding to "Protect Historic Properties and Cultural**
7 **Traditions on Indian Lands"; and**

8 **WHEREAS, the San Xavier District wishes to implement a program entitled HIMDAG GEWKDAG**
9 **(CULTURE IS OUR STRENGTH) in which it will work with middle school children**
10 **teaching them traditional ways and videographing non-ceremonial activities in order**
11 **to preserve our culture for future generations; and**

12 **WHEREAS, the Tohono O'odham Nation is not planning to apply for this funding; and**

13 **WHEREAS, the Tohono O'odham Cultural Preservation Committee and the Tohono O'odham**
14 **Budget and Finance Committee are in support of this application; and**

15 **WHEREAS, the San Xavier District is eligible for the National Park Service funding, provided a**
16 **concurring resolution is obtained from the Tohono O'odham Legislative Council; and**

17 **WHEREAS, the San Xavier O'odham Ap'edag Ki: (People Wellness House) has the capacity to**
18 **implement this project and the District's Grants Manager and Finance Department**
19 **have the capacity to administer this award; and**

20 **WHEREAS, the San Xavier District agrees to accept all responsibilities for the implementation of**
21 **this grant; and**

22 **WHEREAS, the San Xavier District Council, at its regular meeting on April 15, 2009 approved**
23 **submission of this grant and requested a concurring resolution from the Tohono**
24 **O'odham Legislative Council.**

25 **NOW, THEREFORE BE, IT RESOLVED that the Tohono O'odham Legislative Council hereby**
26 **approves and authorizes the San Xavier District to submit its application for the FY**
27 **2010 Application to the National Park Service: Tribal Preservation Program, and to**
28 **administer the grant program if awarded.**

29 **BE IT FINALLY RESOLVED that the San Xavier District assumes all liability resulting from the**
30 **implementation of the FY 2010 Application to the National Park Service: Tribal**
31 **Preservation Program, and to administer the grant program if awarded.**




