## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Appointing Michael T. Telep, Jr. to the Tohono O'odham Judicial Court)

RESOLUTION NO. 10-016

1	WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint judges to
2	the Tohono O'odham Judicial Court pursuant to the Constitution of the Tohono
3	O'odham Nation, ("Constitution") which states, "The Tohono O'odham Courts shall be
4	courts of record and shall consist of at least six (6) judges appointed by the Tohono
5	O'odham Council." (Constitution, Article VIII, Section 3); and
6	WHEREAS, the Constitution requires the judges' terms to be staggered so that two judges shall be
7	appointed every other year (Constitution, Article VIII, Section 4); and
8	WHEREAS, pursuant to 6 T.O.C. Chapter 1, Section 1103(B), "A judge shall continue in office, even
9	if the judge's term has expired, until a successor is appointed and sworn in."; and
10	WHEREAS, Judge Linda Parley's term expired on February 1, 2009 and her subsequent resignation
11	left a vacancy on the Tohono O'odham Judicial Court for a term ending January 31,
12	2015; and
13	WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to the
14	Tohono O'odham Judicial Court, has accepted and reviewed each judicial candidate's
15	application packet and background information; and
16	WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to the
17	Tohono O'odham Judicial Court, has interviewed each judicial candidate who
18	submitted a complete application; and
19	WHEREAS, the Legislative Council has likewise interviewed and considered each judicial
20	candidate appearing before the Council.
21	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
22	appoints Michael T. Telep, Jr. as a Tohono O'odham Judicial Court judge for a term
23	beginning on the effective date of this resolution and ending January 31, 2015.
24 25 26	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>07<sup>TH</sup></u> Day of <u>JANUARY, 2010</u> at a meeting at which a quorum was present with a vote of <u>2,042.40</u> FOR; <u>553.10</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>[01]</u> ABSENT, pursuant to the powers vested in the Council by Section
27	3 of Article VIII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
