1	WHEREAS, the Tonono O'odnam Legislative Council is vested with the power to appoint judges to
2	the Tohono O'odham Judicial Court pursuant to the Constitution of the Tohono
3	O'odham Nation, ("Constitution") which states, "The Tohono O'odham Courts shall be
4	courts of record and shall consist of at least six (6) judges appointed by the Tohono
5	O'odham Council." (Constitution, Article VIII, Section 3); and
6	WHEREAS, the Constitution requires the judges' terms to be staggered so that two judges shall be
7	appointed every other year (Constitution, Article VIII, Section 4); and
8	WHEREAS, pursuant to 6 T.O.C. Chapter 1, Section 1103(B), "A judge shall continue in office, even
9	if the judge's term has expired, until a successor is appointed and sworn in."; and
10	WHEREAS, Judge Betsy Norris' term expired on January 31, 2007 and left a vacancy on the Tohono
11	O'odham Judicial Court for a term ending January 31, 2013; and
12	WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to the
13	Tohono O'odham Judicial Court, has reviewed each judicial candidate's application
14	packet and background information, and has interviewed each judicial candidate who
15	submitted a complete application; and
16	WHEREAS, the Legislative Council has likewise interviewed and considered each judicial
17	candidate appearing before the Council.
18	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it
19	hereby appoints Maria C. Borbon as a Tohono O'odham Judicial Court judge for a term
20	beginning on the effective date of this resolution and ending January 31, 2013.
