6 **Nation, and does hereby order that their name(s) be deleted from the membership roll**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH. Day**
8 **of FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 2,389.20 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and 206.30[03] ABSENT, pursuant to the powers vested in the Council**
10 **by Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'odham**
11 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
12 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
13 **of the Act of June 18, 1934 (48 Stat. 984).**
