## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Accepting Certification of Eligible Members and Authorizing the Initial Expenditure of Funds for Per Capita Payments under the Initiative)

RESOLUTION NO. 10-022

1	WHEREAS,	on June 28, 1997 the voters of the Tohono O'odham Nation (the Nation) approved
2		Initiative No. IN-01-97 (the "Initiative"); and
3	WHEREAS,	the Initiative authorized funding from Gaming Revenues for several measures,
4		including a one-time per capita distribution of \$2,000.00 to each member of the
5		Nation enrolled on June 28, 1997 (the Initial Per Capita Distribution); and
6	WHEREAS,	pursuant to Resolution No. 97-451, the Tohono O'odham Legislative Council adopted
7		an Initiative Funding and Implementation Plan (the FIP) which authorized the
8		establishment of set-aside accounts for the Initial Per Capita Distribution and other
9		Initiative measures, and set certain conditions on the expenditure of funds from such
10		accounts; and
11	WHEREAS,	pursuant to Resolution No. 97-478, the Tohono O'odham Legislative Council approved
12		the transfer of funds from the Desert Diamond Savings Account to certain designated
13		set-aside accounts established at Bank of America, including the sum of \$41.5 million
14		to a set-aside for the Initial Per Capita Distribution (the Per Capita Account); and
15	WHEREAS,	three of the conditions to expenditure of the Per Capita Account specified in the FIP
16		are (1) approval by the Secretary of the Interior of a Per Capita Distribution plan (the
17		Revenue Allocation Plan) pursuant to the requirements of the Indian Gaming
18		Regulatory Act, 25 U.S.C. §2710 (b) (3); (2) acceptance by the Tohono O'odham
19		Legislative Council of a Certification of Eligible Members submitted by the
20		Enrollment Office and based upon receipt of a properly completed and filed
21		Certificate of Eligibility Verification for a Per Capita Payment for each member; and
22		(3) as to each Minor Eligible Member, establishment of a restricted account at Bank
23		of America for the deposit of such Member's Per Capita Payment; and
24	WHEREAS,	pursuant to Resolution No. 97-452, the Tohono O'odham Legislative Council adopted
25		a Revenue Allocation Plan and caused the Plan to be submitted for approval by the
26		Phoenix Area Office of the Bureau of Indian Affairs in accordance with authority
27		delegated to the Area Office by the Secretary of the Interior; and
28	WHEREAS,	by letter dated December 18, 1997 the Area Office approved the Revenue Allocation
29		Plan with respect to the Initial Per Capita Distribution and disapproved the Plan with
30		respect to the Biennial Per Capita Payments; and

**RESOLUTION NO. 10-022** (Accepting Certification of Eligible Members and Authorizing the Initial Expenditure of Funds for Per Capita Payments under the Initiative) Page 2 of 4 WHEREAS, pursuant to Resolution No. 2000-472 the FIP was amended by Amendment No. 1 and 1 further amended by Amendment 2; and Amendment No. 2 requires an Agreement 2 with a reputable financial institution for the establishment of restricted accounts for 3 Minor Eligible Members; and 4 WHEREAS, an Agreement has been negotiated with Wells Fargo for the establishment of 5 restricted accounts for Minor Eligible Members; and 6 WHEREAS, the Tohono O'odham Legislative Council has accepted and approved Certifications 7 of Eligible Members for the Initial Per Capita Distribution, and disbursements have 8 9 been made to such Members: and WHEREAS, the Enrollment Office has filed with the Tohono O'odham Legislative Council a 10 11 Certification of Eligible Members listing 44 adult members who are eligible for 12 receipt of the Initial Per Capita Distribution; and WHEREAS, all conditions under the applicable laws of the United States and the Nation have 13 been satisfied to permit the disbursement of the Initial Per Capita Distribution to the 14 Members listed in the Certification of Eligible Members. 15 NOW, THEREFORE, BE IT RESOLVED THAT: 16 1. The Tohono O'odham Legislative Council hereby accepts and approves the 17 Certification of Eligible Members, in the form attached hereto. 18 2. The Tohono O'odham Legislative Council authorizes (a) the transfer of the sum of 19 \$88,000.00 from the Per Capita Account to the special checking account 20 established at Bank of America (the Per Capita Checking Account); and (b) upon 21 the authorized signature of the Nation, issuance of a check on the Per Capita 22 Checking Account in the amount of (I) \$2,000.00 to each Eligible Member residing 23 in the United States and listed in the attached Certification of Eligible Members, 24 and (ii) \$1,400.00 to each Eligible Member residing outside the United States and 25 listed in the attached Certification, with the balance of \$600.00 withheld and 26 remitted to the Internal Revenue Service pursuant to the requirements of federal 27 law. 28 3. The Chairman of the Nation is authorized to execute such other documents as 29 may be necessary to implement this Resolution. 30
