5	Additional Apportionment of Gaming Revenues to the District with Pisinemo District						
6	receiving Gaming Interest earned in the amount \$5,565.00; and						
7	WHEREAS, the Pisinemo District Council has identified unspent funding in the amount of \$195.00						
8	in its FY 2010 Operating Budget Per Diem line item; and						
9	WHEREAS, the Pisinemo District Council has agreed to combine both the unspent funding and						
10	Additional Apportionment of Gaming Revenues to the District which would cover the						
11	correct amount needed to hire 3 casual laborers and one supervisor under the						
12	Pisinemo Districts Casual Labor line item.						
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves						
14	the Pisinemo District to use the Additional Apportionment of Gaming Revenues to the						
15	Districts in the amount of \$5,565.00. The Pisinemo District Casual Labor Line Item has						
16	been increased to cover the hiring of 3 Casual Laborers and One Supervisor.						
17	BE IT FURTHER RESOLVED that the FY 2010 Pisinemo District Budget is hereby increased from						
18	\$1,863,072.77 to \$1,868,637.77.						
19	BE IT FINALLY RESOLVED that any amendments affecting the funds or funding level of this budget						
20	shall be submitted to the Tohono O'odham Legislative Council for further prior						
21	approval.
