

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval and Acceptance of the Application of the ARRA Energy Efficiency and  
Conservation Block Grant)**

**RESOLUTION NO. 10-036**

1 **WHEREAS, the American Recovery and Reinvestment Act of 2009, Public Law 111-5, appropriated**  
2 **funding to the Department of Energy (DOE) to award formula-based grants to Tribes**  
3 **under the Energy Efficiency and Conservation Block Grant (EECBG) Program; and**

4 **WHEREAS, the U.S. Department of Energy (DOE) ARRA Energy Efficiency and Conservation Block**  
5 **Grant has allocated \$250,000.00 to the Tohono O'odham Nation to develop an Energy**  
6 **Efficiency and Conservation Strategy; and**

7 **WHEREAS, the Tohono O'odham Nation Environmental Protection Office wishes to retain**  
8 **technical assistance services to assist in the development of a strategy and**  
9 **identification of strategies to achieve those goals through efforts to increase energy**  
10 **efficiency, reduce fossil fuel emissions or by encouraging behavioral changes; and**

11 **WHEREAS, the ARRA Energy Efficiency and Conservation Block Grant extends from September 23,**  
12 **2009 through September 22, 2012.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**  
14 **the ARRA Energy Efficiency and Conservation Block Grant award of \$250,000.00.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Chairperson and any designated official to expend and administer the budget as**  
17 **attached provide that any amendments affecting the funds or funding level shall be**  
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
20 **of FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**  
22 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**


