**(Approval of the FY 2010 Tohono O'odham Department of Health and Human**  
**Services, Division of Community Health – Family Violence Services Grant,**  
**Budget Amendment No.1, Account # 11-1477)**

**RESOLUTION NO. 10-037**

- 1 **WHEREAS, prevention of injuries is a priority for the Tohono O'odham Nation; and**
- 2 **WHEREAS, domestic violence is a source of injuries from the individuals and family members;**
- 3 **and**
- 4 **WHEREAS, the Domestic Violence Program within the Department of Health and Human Services,**
- 5 **Community Health Division, and the Domestic Violence Coalition are working to raise**
- 6 **awareness of domestic violence and continue the development of services for**
- 7 **domestic violence victims and their families; and**
- 8 **WHEREAS, there was an increase in the 2010 award amount from projected \$133,198.00 to**
- 9 **\$139,610.00, an increase of \$6,412.00; and**
- 10 **WHEREAS, increases were added to the following operational lines: 650 Tuition & Registration**
- 11 **(\$300.00), 655 Lodging (\$500.00), 660 Travel Expense (\$1,000.00), 700 Advertisement**
- 12 **(\$600.00), 711 Communication Expense (\$200.00), 721 Supplies–Other (\$200.00), 722**
- 13 **Program Supplies (\$300.00), 810 Professional Services (\$2,000.00) and 856 Client**
- 14 **Support (\$712.15) for a total increase to operational of \$5,812.15; and**
- 15 **WHEREAS, an increase to Indirect Cost of \$599.85 adjusting the total award amount of the budget**
- 16 **to \$139,610.00 for FY 2010.**
- 17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**
- 18 **1. Approves the adjustment of the FY 2010 Family Violence Budget from \$ 133,198.00**
- 19 **to a new budget total of \$139,610.00 through this Budget Amendment No. 1.**
- 20 **2. Approves increases to lines 650, 655, 660, 700, 711, 721, 722, 810 and 856 for a total**
- 21 **increase to operational line items of \$5,812.15.**
- 22 **3. Approves an increase to Indirect Cost of \$599.85 for a total increase of \$6,412.00**
- 23 **and a total budget award of \$139,610.00.**
- 24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
- 25 **Nation's official, to wit: the Chairman and Vice Chairman and any designated official**
- 26 **are authorized to administer and expend these funds, provided however, that any**
- 27 **amendment affecting the funds or funding levels shall be submitted for further prior**
- 28 **approval by the Tohono O'odham Legislative Council.**






