

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Standards of Conduct for Legislative Council Representatives and Alternates)**

LEGISLATIVE ORDER NO. 10-041

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative**
2 **Council with the power "to establish rules and procedures to regulate all meetings of**
3 **the Tohono O'odham Council, standing committees, boards, and special committees."**
4 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, Legislative Council representatives and alternates ("Council Representatives") are**
6 **also representatives of the Tohono O'odham Nation and are therefore expected to**
7 **conduct themselves in a manner which reflects favorably upon the Tohono O'odham**
8 **and government of the Tohono O'odham Nation; and**

9 **WHEREAS, the Legislative Rules Committee has developed the attached "Standards of Conduct**
10 **for Legislative Council Representatives and Alternates" as dated for reference January**
11 **2010 ("Standards of Conduct") to ensure that Council Representatives meet the high**
12 **standards set forth in the Standards of Conduct; and**

13 **WHEREAS, the Rules Committee has solicited input from Council Representatives on the**
14 **proposed Standards of Conduct and recommends its adoption; and**

15 **WHEREAS, it is in the best interest of the Tohono O'odham Nation and its members that the**
16 **Legislative Council adopt the Standards of Conduct.**

17 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
18 **adopts the Standards of Conduct.**

19 **BE IT FINALLY ORDERED that the Rules Committee and Council Chairperson shall jointly provide**
20 **the Legislative Council with a written status report on the implementation of the**
21 **Standards of Conduct within six months.**

22 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 09TH day of**
23 **FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 1,849.80 FOR; 745.70**
24 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**


