

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting the Title IV-E Planning grant in accordance with Resolution No. 99-059 and
Approving the FY 2010 Department of Health and Human Services Title IV-E Budget,
for Division of Child Welfare; and Approving the 19.35% Indirect Cost Rate)

RESOLUTION NO. 10-046

1 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a**
2 **Division of Child Welfare Services to intervene against child abuse and neglect and**
3 **to promote safe and stable families; and**

4 **WHEREAS, the Child Welfare Division and the Department of Health and Human Services wishes**
5 **to plan and implement standards in accordance with Administration of Children,**
6 **Youth, and Families Children's Bureau for the direct reimbursement for The**
7 **Fostering Connections to Success and Increasing Adoptions Act of 2008 (Public Law**
8 **110-351) added a new section 479B to the Social Security Act (the Act) which allows**
9 **Indian tribes the option to apply to the Secretary to receive Federal funding to**
10 **support the administration of their own foster care, adoption assistance and**
11 **guardianship assistance programs under Title IV-E of the Act. This is a onetime**
12 **development grant for \$300,000.00 to be used to offset the cost of developing a Title**
13 **IV-E plan to carry out the requirements of new section 479B of the Act; and**

14 **WHEREAS, the Child Welfare Division plans to implement a Title IV E foster care, adoption**
15 **assistance and at Tribal option, guardianship assistance program. Funds will be**
16 **used for costs relating to the development of data collection systems, a cost**
17 **allocation plan, agency and tribal court procedures necessary to meet the case**
18 **review system requirements under section 475(5) of the Act, or any other costs**
19 **attributable to meeting any other requirement necessary for approval of a Title IV-E**
20 **plan; and**

21 **WHEREAS, the Executive Branch developed and obtained committee approval of the budget**
22 **attached and incorporated by this reference, to be effective October 1, 2009 through**
23 **September 30, 2011 and requests authorization to expend funds over the fiscal year**
24 **of FY 2010 totaling \$300,000.00 with Indirect Cost charges of 19.35%, in addition any**
25 **unexpended funds shall be carried over into FY 2011 for the plan period of 24**
26 **months; and**

27 **WHEREAS, the Tohono O'odham Legislative Council approves the Grant in accordance with**
28 **Resolution No. 99-059, "Approving the Process for Grant fund application".**

1 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
2 accepts the grant, approves and authorizes the Executive Branch to expend funds for
3 the budget attached, effective October 1, 2009 through September 30, 2011 and
4 requests authorization to expend funds for FY 2010 totaling \$300,000.00 with
5 Indirect Cost charges of 19.35%. Any unexpended funds will be carried over into FY
6 2011 for the plan period of 24 months.

7 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby Authorizes
8 Chairman and any designated official to expend and administer the budget as
9 attached, provided that any budget amendments affecting the funds or funding
10 levels shall be submitted for further prior approval by the Tohono O'odham
11 Legislative Council.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
13 of FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-
14 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article
15 VI, Section 1 (d)(2)(3)&(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
16 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
18 Stat. 984).


