

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Healthy O'odham Promotion Program (HOPP) New Award FY 2010 Budget)**

**RESOLUTION NO. 10-048**

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Program for Indians grant**  
2 **through FY 2010 with a base budget of \$1,929,827.00; and**

3 **WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the**  
4 **establishment of the Community Based Diabetes Prevention Program, funded by the**  
5 **Special Diabetes Program for Indians, authorized by the Balanced Budget Act of 1997;**  
6 **and**

7 **WHEREAS, by Resolution Number 2000-182, the Tohono O'odham Legislative Council approved**  
8 **the name change of the Community Based Diabetes Prevention Program to the**  
9 **Healthy O'odham Promotion Program; and**

10 **WHEREAS, the HOPP Program received a Notice of Award (NOA) for a new funding cycle covering**  
11 **a two year period December 7, 2009 to September 30, 2011, a new account number is**  
12 **needed; and**

13 **WHEREAS, to keep separate any accounting discrepancies that may occur between the approved**  
14 **Resolution No. 09-279 for the FY 2010 budget and the new FY 2010 NOA dated**  
15 **December 7, 2009 to September 30, 2011, a new account number is needed; and**

16 **WHEREAS, the Executive Office, the Health and Human Service Oversight Committee and the**  
17 **Budget and Finance Committee has reviewed and approved this budget.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
19 **approves and authorizes expenditures for:**

- 20 **1. Acceptance of the new Notice of Award (NOA) for HOPP from December 7, 2009 –**  
21 **September 30, 2011.**
- 22 **2. Approve the attached FY 2010 budget of \$1,929,827.00.**
- 23 **3. Assigning a new account number for the new two year 2010 NOA covering**  
24 **December 7, 2009 to September 30, 2011.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairman, and any designated official to expend and administer the budget, as**  
27 **attached, provided that any amendments affecting the funds or funding level shall be**  
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

7 **Stat. 984).**


