

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the MOU between the Tohono O'odham Nation and the United States  
Marshals Service for the Fugitive Apprehension Task Force)**

**RESOLUTION NO. 10-052**

1 **WHEREAS, the Tohono O'odham Nation ("the Nation") seeks to enter into a Memorandum of**  
2 **Understanding (MOU) with the United States Marshals Service (USMS) on behalf of the**  
3 **Nation's Police Department pursuant to the Presidential Threat Protection Act of 2000**  
4 **to establish a Fugitive Apprehension Task Force that consists of Federal, State, and**  
5 **local Law Enforcement authorities; and**

6 **WHEREAS, the Task Force will be directed and coordinated by the USMS for the purpose of**  
7 **locating and apprehending fugitives; and**

8 **WHEREAS, the attached MOU has been reviewed by the Domestic Affairs Committee which**  
9 **recommends Legislative Council approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**  
11 **the Memorandum of Understanding between the U.S. Marshals Service and the**  
12 **Tohono O'odham Nation regarding a District Fugitive Apprehension Task Force**  
13 **substantially in the form attached hereto, and hereby authorizes the Chairman of the**  
14 **Nation to sign and execute the MOU with the United States Marshals Service.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council authorizes the Chairman**  
16 **and the Nation's Police Department to fully implement the MOU provided that any**  
17 **amendments shall be submitted for full approval by the Tohono O'odham Legislative**  
18 **Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>. Day**  
20 **of FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 2,184.50 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and 411.0 [08] ABSENT, pursuant to the powers vested in the Council by**  
22 **Article VI, Section 1 (f)(d) of the Constitution of the Tohono O'odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
