

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Setting February 16, 2010 Special Session to Review the FY 2009 KOHN Audit)

LEGISLATIVE ORDER NO. 10-054

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to  
2 regulate all meetings of the Tohono O'odham Council, standing committees, boards  
3 and special committees." (Constitution of the Tohono O'odham Nation, Article VI,  
4 Section 1(a)); and

5 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with  
6 the authority to "by majority vote, call for a special session" (Legislative Rules of the  
7 Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 WHEREAS, the Legislative Council Budget and Finance Committee has requested a special session  
9 on February 16, 2010 at 1:00 p.m. to review the FY 2009 KOHN audit.

10 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby  
11 sets a special session on February 16, 2010 at 1:00 p.m. to review the FY 2009 KOHN  
12 audit.

13 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> day of  
14 FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 1,991.50 FOR; 399.30  
15 AGAINST; -0- NOT VOTING; and 204.70[08] ABSENT, pursuant to the powers vested in the Council  
16 by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the  
17 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
19 18, 1934 (48 Stat. 984).
