5		enrolled on June 28, 1997; and
6	WHEREAS,	pursuant to Resolution No. 97-451, the Tohono O'odham Legislative Council (the
7		$\hbox{``Legislative Council'') adopted an Initiative Funding and Implementation Plan which}$
8		authorized the establishment of set-aside accounts for the Initial Per Capita
9		Distribution; and
10	WHEREAS,	pursuant toResolutionNo.2000-269and2000-472, theLegislativeCounciladopted(1)
11		${\bf a Second Initiative Funding and Implementation Plan, (2) a Second Revenue Allocation}$
12		Plan (the "Second Per Capita") wherein each eligible member is entitled to receive a
13		per capita payment of \$2,000.00; and
14	WHEREAS,	the funds for eligible minor members from the Initiative and Second Per Capita were
15		set aside and earned interest for the period from December 1997 to December 2009
16		for the Initiative and for the period from November 2000 to December 2009 for the
17		Second Per Capita; and
18	WHEREAS,	the minor members eligible for the Initiative and Second Per Capita were certified
19		upon reaching age 18 years old and were paid \$2,000.00 without interest earned; and
20	WHEREAS,	the Nation's Treasurer calculated interest due to the minor members eligible for the
21		Initiative and Second Per Capita herein attached; and
22	WHEREAS,	the NationengagedEideBailly("Auditors")toconductareviewoftheMinors'Initiative
23		and Second Per Capita eligibility determination, distributions; and interest
24		calculation; and
25	WHEREAS,	the AuditorshavecompletedtheAgreedUponProceduresReportfortheInitiativeand
26		Second Per Capita; and
27	WHEREAS,	pursuant to Resolution No. 09-506 the Nation accepted the Agreed Upon Procedures
28		Report and updated the report through December 2009.

6	Fargo Bank until the eligible member reaches the age of 18 years old and (b)
7	distribution of interest income funds due to each eligible minor who has reached
8	the age of 18 years old for the Initiative and Second Per Capita Plans.
9	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Chairman
10	and Vice-Chairman of the Nation to executive such other documents as may be
11	necessary to implement this Resolution.
