**RESOLUTION NO. 10-057**

1 **WHEREAS, the Tohono O'odham Legislative Council by Res. No. 09-425 has apportioned to the**  
2 **Hickiwan District from the FY2009 Gaming Revenues the Equal Distribution amount**  
3 **of \$1,863,072.77 and 20% of the Host Share in the amount of \$39,031.32 to a total of**  
4 **\$1,902,104.09; and**

5 **WHEREAS, the Legislative Council by Res. No. 09-517 approved the Hickiwan District**  
6 **Administration and six community budgets in the amount of \$1,865,104.09, and setting**  
7 **aside the Hickiwan Community apportioned revenue of \$37,000.00 in reserve until a**  
8 **budget is formulated, presented and approved by the Hickiwan District Council and**  
9 **Legislative Council; and**

10 **WHEREAS, the Hickiwan District Council by Res. No. HDC-09-156 has approved the Hickiwan**  
11 **Community FY2010 Budget in the amount of \$37,000.00 as presented by the Hickiwan**  
12 **Community Representative at a duly called meeting on December 12, 2009; and**

13 **WHEREAS, the Hickiwan District Council recommends approval of the Hickiwan Community**  
14 **FY2010 Budget in the amount of \$37,000.00 and that it be added to the Hickiwan**  
15 **District FY2010 Budget of \$1,865,104.09 to bring the total to \$1,902,104.09.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
17 **the Hickiwan Community FY2010 Budget in the amount of \$37,000.00 bring the total**  
18 **of the Hickiwan District FY2010 Budget to the amount of \$1,902,104.09.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the budget as**  
21 **attached, provided that any amendments affecting the funds or funding level shall be**  
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>. Day**  
24 **of FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 1,971.40 FOR; 449.60**  
25 **AGAINST; 174.50 [05] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council**  
26 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
27 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**
