

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Services, Division of Family Assistance – FY2010 Tribal Food Distribution Program Budget Amendment #1 - Account No. 01-1315)**

**RESOLUTION NO. 10-058**

1 **WHEREAS, by Resolution Number 09-268, the Tohono O'odham Legislative Council approved the**  
2 **FY2010 Food Distribution Program Tribal budget in the amount of \$81,331.14; and**

3 **WHEREAS, the Nation was notified of the final grant award for the Food Distribution Program**  
4 **USDA budget with an increase in funding which funding requirement is at a 75% match**  
5 **by USDA and a 25% match by Tribal funds; and**

6 **WHEREAS, due to the increased USDA funding, the Tribal match has decreased from \$81,331.14**  
7 **to \$78,230.00, a decrease of \$3,101.14; and**

8 **WHEREAS, the Executive Branch developed and obtained committee approval for the Department**  
9 **of Health and Human Services, Tribal Food Distribution Program Budget Amendment**  
10 **#1 which decreases the Food Distribution Program Tribal funding by \$3,101.14 and**  
11 **decreases line items: 712 Gas, Oil and Coolants by \$1,465.14; 770 RM Equipment by**  
12 **\$1,000.00 and 771 RM Vehicles by \$636.00 to be effective October 01, 2009 through**  
13 **September 30, 2010, and requests authorization to expend these funds.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
15 **approve Budget Amendment #1 which decreases the Food Distribution Program Tribal**  
16 **funding by \$3,101.14, from \$81,331.14 to \$78,230.00 and decreases line items: 712 Gas,**  
17 **Oil and Coolants by \$1,465.14; 770 RM Equipment by \$1,000.00 and 771 RM Equipment**  
18 **by \$636.00 to be effective October 01, 2009 through September 30, 2010.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the budget as**  
21 **attached, provided that that any amendments affecting the funds or funding level**  
22 **shall be submitted for further prior approval by the Tohono O'odham Legislative**  
23 **Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>. Day**  
25 **of FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**  
27 **VI, Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**
