

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu-Vo District Administration Amendment #2 Fiscal Year 2010)**

RESOLUTION NO. 10-060

1 **WHEREAS, the Gu-Vo District did bring forth the Gu-Vo District Administration's Amendment No.**
2 **2 for the Fiscal Year 2010 budget; and**

3 **WHEREAS, the Gu-Vo District Administration is requesting adjustment to the justification in their**
4 **FY' 2010 Budget to assist the District Members; and**

5 **WHEREAS, the proposed amendment from the Administration has gone through proper reviews**
6 **from the Gu-Vo District and the Tohono O'odham Legislative Budget and Finance**
7 **Committee; and**

8 **WHEREAS, it is the recommendation of the Budget & Finance Committee to approve Amendment**
9 **#2 for Gu-Vo District Administration.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **the Budget Amendment #2 for Gu-Vo District Administration and adjusting the**
12 **amount and the justification of line items; 727; 750, and 860 in their FY' 2010 Budget.**

13 **727 - Building Material: decreased in the amount of \$8,000.00**

14 **750- Major Capital Equipment: to provide the purchase of one 12 passenger van and**
15 **trade in (1) vehicle, for the district members to be transported to place of**
16 **business, Administration for meetings, etc.**

17 **\$6,000.00 is budgeted for the minivan with ramp from A.D.O.T.**

18 **860 - Special Activities: to cover the cost of having the District Day, District Clean Up**
19 **Day, Holidays;**

20 **\$2,000.00 - t-shirts & other incentives for Native American AIDS Day.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH. Day**
22 **of FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
24 **VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**
