1 **WHEREAS, Sells District-Ge Oidak Community Resolution No. GO-50-09; Sells District Council**
2 **Resolution No. SD-83-09; Legislative Council Resolution No. 09-525 approved the Sells**
3 **District-Ge Oidak Community Fiscal Year 2010 Budget and its justification; and**

4 **WHEREAS, the Ge Oidak Community has prepared and acquired approvals of the attached budget**
5 **Modification and its justification with Ge Oidak Community Resolution No. GO-23-10;**
6 **Sells District Council Resolution No. SD-03-10; for adjustments to continue addressing**
7 **the needs of the people; and**

8 **WHEREAS, this Modification will increase the amount of the line item for 612-Occasional**
9 **Appointments by \$15,000.00; and**

10 **WHEREAS, the increase will reduce the budgeted amounts for Line Items 720-Office Supplies by**
11 **\$500.00; 727-Materials by \$2,000.00; 759-Equipment Other by \$12,500.00.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
13 **Sells District-Ge Oidak Community Fiscal Year 2010 Budget Modification No. 1 of**
14 **Gaming Revenues.**

15 **BE IT FURTHER RESOLVED that this Modification will increase the amount of the line item for 612-**
16 **Occasional Appointments by \$15,000.00 which will reduce the budgeted amounts for**
17 **Line Items 720-Office Supplies by \$500.00; 727-Materials by \$2,000.00; 759-Equipment**
18 **Other by \$12,500.00 and this Budget Modification does not affect the overall total**
19 **amount.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
21 **District Chairperson and any designated District Official to expend and administer the**
22 **budget, as attached, provided that any modifications/amendments affecting the funds**
23 **or funding levels of the budget shall be submitted for further prior approval by the**
24 **Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day**
26 **of FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 2,246.40 FOR; 349.10**
27 **AGAINST; 02 NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Article**
28 **VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
29 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**
