5	\$25,638.21 of their \$58,275.83 budget; and
6	WHEREAS, the attached budget amendment and its justifications has been prepared and
7	approved by the Cowlic Community with Resolution No. CC-03-10; by the Sells District
8	Council with Resolution No.SD-17-10 approving a carry forward of the remaining
9	balance to be utilized to address the additional needs of the people.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
11	Cowlic Community Fiscal Year 2010 Budget Amendment No. 1 to Carry Forward
12	\$25,638.21 of Gaming Revenues from Fiscal Year 2009 to their Fiscal Year 2010 budget
13	of \$62,000.00 for a new Grand Total of \$87,638.21 for Fiscal Year 2010 for the Cowlic
14	Community Budget.
15	BE IT FURTHER RESOLVED that this will increase the Sells District budget by \$25,638.21 adjusting
16	the total Sells District budget for Fiscal Year 2010 from \$1,863,072.77 to a new Grand
17	Total of \$1,888,710.98.
18	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells
19	District Chairperson and any designated official to expend and administer the budget,
20	as attached, provided that any modifications/amendments affecting the funds or
21	funding levels of the budget shall be submitted for further prior approval by the
22	Tohono O'odham Legislative Council.
