10	WHEREAS,	the Cowlic Community has a remaining balance of \$56,506.51 which the community
11		has requested to carryover this amount with Cowlic Community Resolution No. CC-02-
12		10 which was also approved by Sells District Council with Resolution No. SD-11-10.

14		Carryover of Cowlic Community Fiscal Year 2009 Mining Royalties to FY2010 in the
