

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Carryover of Cowlic Community FY 2009 Mining Royalties to FY 2010 in**  
**the amount of \$56,506.51)**

**RESOLUTION NO. 10-068**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 07-752 in Fiscal Year 2007**  
2 **approved the Equal Distribution of \$2,932,566.45 of Mining Royalties to the eleven**  
3 **Districts of the Tohono O'odham Nation; and**

4 **WHEREAS, the Sells District's portion of this allocation in the amount of \$266,596.95 was not**  
5 **requested in Fiscal Year 2008 but was requested and approved to be utilized in Fiscal**  
6 **Year 2009 with Tohono O'odham Legislative Council Resolution No. 09-140; and**

7 **WHEREAS, the total allocation was portioned among the four communities to address the needs**  
8 **according to the budgets submitted; and**

9 **WHEREAS, the Cowlic Community was allocated \$66,649.23 in FY 2009 of the Mining Royalties; and**

10 **WHEREAS, the Cowlic Community has a remaining balance of \$56,506.51 which the community**  
11 **has requested to carryover this amount with Cowlic Community Resolution No. CC-02-**  
12 **10 which was also approved by Sells District Council with Resolution No. SD-11-10.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
14 **Carryover of Cowlic Community Fiscal Year 2009 Mining Royalties to FY2010 in the**  
15 **amount of \$56,506.51 with the attached approved budget and it's justification.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Sells District Chairperson and any designated official to expend and administer the**  
18 **budget according to its justification, as attached, provided that any**  
19 **modifications/amendments affecting the funds or funding levels of the budget shall**  
20 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day**  
22 **of FEBRUARY, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-**  
23 **AGAINST; 187.10[02] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**  
24 **by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
