NOW. THEREFORE. BE IT RESOLVED THAT: 16 17 1. The Tohono O'odham Legislative Council hereby accepts and approves the 18 Certification of Eligible Members, in the form attached hereto. 19 2. The Tohono O'odham Legislative Council authorizes Wells Fargo Bank to 20 commence the payments to the eligible members identified in the form attached hereto as they are no longer restricted beneficiaries. 21 3. The Chairman of the Nation is authorized to execute such other documents as 22 23 may be necessary to implement this Resolution. The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08^{TR} Day 24 25 of MARCH, 2010 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-26 AGAINST; 01 NOT VOTING; and 174.50 [04] ABSENT, pursuant to the powers vested in the Council by 27 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by 28 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant 29 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June **30** 18, 1934 (48 Stat. 984). 31 32 33 34 35
