7		distribution payments in accordance with the Initiative (See Legislative Council

9	WHEREAS,	the Legislative Council adopted the Per Capita Revenue Allocation Plan for a per
10		capita distribution per Legislative Council Resolution No. 09-164; and
11	WHEREAS,	the Chairman of the Nation received written notification from the Department of the
12		Interior on June 15, 2009 that the Nation's Revenue Allocation Plan is approved; and
13	WHEREAS,	the  Nation's  Department  of Membership  Services, Enrollment  Program  submits  to  the  Membership  Services,  Consideration  Services  and  Consideration  Services  and  Consideration  Services  and  Consideration  and  Consideration

16	WHEREAS,	pursuant to Resolution No. 09-428 which approved the Master List for certification,

18		distribution is 19,141; and
19	WHEREAS,	the disbursement of funds to each eligible adult member is contingent upon
20		$verification \ of \ a \ member\ and\ further\ certification\ by\ the\ Tohono\ O'odham\ Legislative$
