16	WHEREAS,	the Legislative Council approved the Monthly Age 18 Report for the period December
17		2009 through February 2010 on February 10, 2010, pursuant to Resolution No.10-025-000000000000000000000000000000000
18		Approving the "Monthly Age 18 Report" listing of Tohono O'odham Eligible Minor
19		members and authorizing commencement of payment of the Third Per Capita
20		Payment held on their behalf by Wells Fargo Bank; and
21	WHEREAS,	the Enrollment Program has now identified 1 individual that was incorrectly listed as
22		an eligible minor on this legislatively approved Report on February 10, 2010; and
23	WHEREAS,	this individual's name should be removed from the February 10, 2010, approved
24		"Monthly Age 18 Report" because the individual was not a minor but an adult; and
25	WHEREAS,	pursuant to Resolution No. 06-627 approval of eligible Tohono O'odham Minor
26		Members for set-up of minor accounts are contingent upon verification and
27		certification by the Tohono O'odham Legislative Council.
