

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the removal of a minor from the legislatively approved Certification Listing for eligible Tohono O'odham Minor Members for the Fourth Per Capita Distribution)**

**RESOLUTION NO. 10-078**

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the "Tohono**  
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per**  
3 **capita payments to the Nation's members provided that sufficient gaming revenues**  
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**  
6 **Nation, was subsequently amended to authorize per capita distribution payments in**  
7 **accordance with the Initiative (Legislative Council Resolution No. 97-303); and**

8 **WHEREAS, the Fourth Per Capita Revenue Allocation Plan "(Revenue Allocation Plan)" which**  
9 **authorizes the fourth per capita payment to all eligible Tohono O'odham members**  
10 **was adopted by the Tohono O'odham Legislative Council, Resolution No. 09-164; and**

11 **WHEREAS, on June 15, 2009, the Department of Interior approved the Revenue Allocation Plan;**  
12 **and**

13 **WHEREAS, in accordance with the Revenue Allocation Plan, the Tohono O'odham Membership**  
14 **Services presented the Master List for Eligible Tohono O'odham Minor Members for**  
15 **the Fourth Per Capita Distribution and established the number of eligible minor**  
16 **members at 8,664 members pursuant to Resolution No. 09-429; and**

17 **WHEREAS, the Tohono O'odham Legislative Council established the number of eligible minor**  
18 **members at 8,664 pursuant to Resolution No. 09-429, "Approving the Master List for**  
19 **the Fourth Per Capita Distribution for Eligible Tohono O'odham Minor Members"; and**

20 **WHEREAS, the Enrollment Program submitted to the Tohono O'odham Legislative Council a**  
21 **Certification Listing of 101 eligible minor members for the fourth per capita**  
22 **distribution because these 101 minors had reached the age of 18; and**

23 **WHEREAS, the Tohono O'odham Legislative Council approved the Certification Listing of 101**  
24 **eligible minor members for the fourth per capita distribution on February 10, 2010,**  
25 **pursuant to Resolution No. 10-029; and**

26 **WHEREAS, the Enrollment Program has now identified one minor member that was incorrectly**  
27 **listed on the Certification Listing approved pursuant to Resolution No. 10-029; and**

1 WHEREAS, the Enrollment Program has determined that this minor member had already  
2 received his fourth per capita distribution and should not have been included on the  
3 Certification Listing approved pursuant to Resolution No. 10-029; and

4 WHEREAS, pursuant to Resolution No. 06-627 approval of eligible Tohono O'odham Minor  
5 Members for set-up of minor accounts are contingent upon verification and  
6 certification by the Tohono O'odham Legislative Council.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts  
8 and approves the removal of the attached list of 1 individual from the "Certification  
9 Listing of Eligible Tohono O'odham Minor Members for the Fourth Per Capita  
10 Distribution" approved by the Legislative Council, Resolution No. 10-029.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day  
12 of MARCH, 2010 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-  
13 AGAINST; -0- NOT VOTING; and 174.50[04] ABSENT, pursuant to the powers vested in the Council  
14 by Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the  
15 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
17 18, 1934 (48 Stat. 984).
