

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Tohono O'odham Department of Health and Human Services - FY 2010  
Division of Behavioral Health I.H.S. Budget Amendment #1-Account No. 10-1473)**

**RESOLUTION NO. 10-079**

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health is**  
2 **currently operating the Behavioral Health Division through an Indian Health Services**  
3 **(I.H.S.) 638 Contract; and**

4 **WHEREAS, pursuant to Legislative Council Resolution No. 09-272, the Department of Health and**  
5 **Human Services, Division of Behavioral Health, was approved by the Legislative**  
6 **Council in the May general session; and**

7 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health request**  
8 **to amend the current resolution in the amount of \$2,327,384.53 to \$2,431,277.53 an**  
9 **increase of \$103,893.00. The Direct Cost is amended from \$1,982,601.00 to**  
10 **\$2,086,494.00 with an increase of \$103,893.00 reflecting the I.H.S. Annual Funding**  
11 **Agreement increase for the Division of Behavioral Health; there is no change to the**  
12 **Indirect Cost; and**

13 **WHEREAS, the special medical services line item is increased and adding new line item Major**  
14 **Capital to provide additional behavioral health services; and**

15 **WHEREAS, the FY2010 Division of Behavioral Health I.H.S. Budget Amendment #1 in the amount**  
16 **of \$2,431,277.53, has been submitted for review by the Health and Human Services**  
17 **Committee for the Division of Behavioral Health.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 19 **1. The attached FY2010 Division of Behavioral Health I.H.S. Budget Amendment #1**  
20 **approves to increase the amount of \$2,327,384.53 to \$2,431,277.53 an increase of**  
21 **\$103,893.00. The Direct Cost is amended from \$1,982,601.00 to \$2,086,494.00 with**  
22 **an increase of \$103,893.00 reflecting the I.H.S. Annual Funding Agreement increase**  
23 **for the Division of Behavioral Health; there is no change to the Indirect Cost.**
- 24 **2. The special medical services line item is increased and adding new line item Major**  
25 **Capital to provide additional behavioral health services.**
- 26 **3. Approves and authorizes expenditures in accordance with the Department of**  
27 **Health and Human Services, Division of Behavioral Health FY2010 I.H.S. Budget**  
28 **Amendment #1 increased in the amount of \$2,431,277.53.**

29 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
30 **Chairperson and any designated official to expend and administer the budget as**




