

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Johnson Jose to the Enrollment Committee)

RESOLUTION NO. 10-080

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**
3 **committees, boards, officers and agents" (Article VI, Section 1(b) of the Constitution**
4 **of the Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has enacted and subsequently amended Ordinance No. 05-81,**
6 **the "Enrollment Ordinance," which establishes an Enrollment Committee to oversee**
7 **enrollment into memberships in the Tohono O'odham Nation; and**

8 **WHEREAS, the Enrollment Ordinance provides that the Enrollment Committee "shall be**
9 **composed of five members of the Tohono O'odham Nation who are bilingual in the**
10 **O'odham and English languages" and whose members "shall be appointed by the**
11 **Chairman of the Nation, subject to the approval by the Tohono O'odham Legislative**
12 **Council" (Enrollment Ordinance, Article II, Section 1.A. and 1.B); and**

13 **WHEREAS, Committee members "shall be appointed for terms of three years or until their**
14 **successors are appointed. The appointments of the five members shall be staggered**
15 **so that no more than two members shall be appointed or reappointed each year."**
16 **(Enrollment Ordinance, Article II, Section 1.C.); and**

17 **WHEREAS, Johnson Jose was appointed by Resolution No. 08-465 to a three-year term on the**
18 **Enrollment Committee with a term ending January 1, 2010 but continues to serve until**
19 **his successor is appointed; and**

20 **WHEREAS, subject to approval by the Legislative Council, the Chairman of the Tohono O'odham**
21 **Nation has reappointed Mr. Johnson Jose to the Enrollment Committee for a three-**
22 **year term ending January 1, 2013; and**

23 **WHEREAS, if approved, Johnson Jose would serve on the Enrollment Committee until January 1,**
24 **2013; provided that he would continue to serve until replaced by a successor who is**
25 **appointed in accordance with the Enrollment Ordinance.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
27 **the appointment of Mr. Johnson Jose to the Enrollment Committee upon the effective**
28 **date of this resolution and ending January 1, 2013; provided that he shall continue to**
29 **serve until replaced by a successor who has been appointed in accordance with the**
30 **Enrollment Ordinance.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day of MARCH, 2010 at a meeting at which a quorum was present with a vote of 1,836.0 FOR; 354.90 AGAINST; 230.10 NOT VOTING; and 174.50[06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (b) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
