

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2010 Carry Forward Budget for Grant Year 2009 Unobligated Child  
Care & Development Fund [CCDF] Discretionary Funds)**

**RESOLUTION NO. 10-081**

1 **WHEREAS, the Tohono O'odham Nation is operating the Division of Early Childhood Development**  
2 **for its young members and providing for their welfare through various programs and**  
3 **services designed to meet their special needs; and**

4 **WHEREAS, the Department of Health and Human Services, Administration for Children and**  
5 **Families has awarded the Tohono O'odham Nation the Child Care & Development**  
6 **Fund (CCDF) for Grant Year 2009 to implement Child Care Services through the**  
7 **Division of Early Childhood Development; and**

8 **WHEREAS, the Child Care & Development Fund is a multi-year grant in which Grant Year 2009**  
9 **unobligated funds will be obligated by September 30, 2010 and liquidated by**  
10 **September 30, 2010; and**

11 **WHEREAS, the proposed FY 2010 Carry Forward Budget for Grant Year 2009 Unobligated CCDF -**  
12 **Discretionary Funds totaling \$63,887.91 has been reviewed and approved by the**  
13 **Human Resources Development Committee and the Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
15 **approve the FY 2010 Carry Forward Budget for Grant Year 2009 Unobligated CCDF -**  
16 **Discretionary Funds totaling \$63,887.91 for the following budget as attached hereto.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Nation's Official, to wit: the Chairman and any designated official are authorized to**  
19 **negotiate and expend the budget, provided however, that any amendments affecting**  
20 **the funds or funding levels of the budget shall be submitted for further prior approval.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
22 **of MARCH, 2010 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and 174.50[06] ABSENT, pursuant to the powers vested in the Council**  
24 **by Article VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted**  
25 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
