9	unobligated funds will be obligated by September 30, 2010 and liquidated by
10	September 30, 2010; and

12	Discretionary Funds totaling \$63,887.91 has been reviewed and approved by the
13	Human Resources Development Committee and the Budget and Finance Committee.

18	Nation's Official, to wit: the Chairman and any designated official are authorized to
19	negotiate and expend the budget, provided however, that any amendments affecting
20	the funds or funding levels of the budget shall be submitted for further prior approval.
