(Approving Choulic Community FY 2010 Budget Amendment #1)

RESOLUTION NO. 10-083

1 **WHEREAS, at a regular scheduled session of the Tohono O'odham Legislative Council, held on**
2 **March 8, 2010; and**

3 **WHEREAS, Baboquivari District Representatives, presented a budget amendment #1 for the**
4 **Choulic Community, to their FY 2010 current budget; and**

5 **WHEREAS, at a Baboquivari District Council meeting held on February 2, 2010, Choulic**
6 **Community's FY 2010 budget amendment #1 was presented, reviewed, discussed and**
7 **approved to amend their FY 2010 budget in the amount of \$17,741.37, by a vote count**
8 **of 9-For, 0-Against, 0-Not Voting, 3-Absent; and**

9 **WHEREAS, the budget amendment #1 requested, is to utilize mining royalties in the amount of**
10 **\$17,741.37, per Baboquivari District Resolution No. 09-B-163; and**

11 **WHEREAS, the budget amendment #1 shall be applied as follows:**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **Choulic Community's FY 2010 Budget Amendment #1, utilizing mining royalties in the**
18 **amount of \$17,741.37.**

19 **BE IT FURTHER RESOLVED that this budget amendment #1 will increase the Choulic Community's**
20 **FY 2010 current budget amount of \$186,307.28 to \$204,048.65 and increases the overall**
21 **Baboquivari District FY 2010 current budget amount \$1,880,814.14 to \$1,898,555.51.**

22 **BE IT FINALLY RESOLVED that any modifications, amendments or changes in the justifications**
23 **shall be reviewed and approved by the Budget and Finance Committee and the Tohono**
24 **O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
26 **of MARCH, 2010 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and 174.50[05] ABSENT, pursuant to the powers vested in the Council**
28 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
