2	Education Department in submitting a grant proposal that established the Vocational
3	Rehabilitation Program under Resolution No. 03-149; and
4	WHEREAS, the Tohono O'odham Nation was awarded a grant under the U.S. Department of
5	Education Office of Special Education Rehabilitative Services/Rehabilitation Services
6	Administration's Section 121 (Vocational Rehabilitation Services Projects for
7	American Indians with Disabilities) of the Rehabilitation Act and received grant
8	notification number H250D080009; and
9	WHEREAS, the Resolution No. 08-614 accepts grant award number H250D080009, and states the
10	total amount of the grant as \$2,164,693.31, and the Grant Award Notification identifies
11	the actual grant award amount is \$2,164,692.00; and
12	WHEREAS, services will be provided to eligible enrolled Tohono O'odham members with
13	disabilities living on or near the Nation, and other federally recognized American
14	Indians with disabilities living on the Nation; and
15	WHEREAS, the services provided will be consistent with individual strengths, resources,
16	priorities, concerns, abilities, capabilities, and informed choice so that they may
17	prepare for, engage in, and maintain gainful employment; and
18	WHEREAS, a carryover amount has been identified from fiscal year 2009 in the amount of
19	\$47,500.61, and is added into the current program budget of \$423,536.00, which will
20	increase the total budget to \$471,036.61.
21	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
22	approves the Vocational Rehabilitation Program's FY 2010 Budget Amendment 1
23	reflecting carryover funds in the amount of \$47,500.61, which will be added to the
24	current program base budget of \$423,536.00 for a grand total of \$471,036.61.
