

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Carry-Over of FY2009 Mining Royalties for the Sells District in the**  
**amount of \$127,189.58 to Fiscal Year 2010)**

**RESOLUTION NO. 10-086**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 09-524, approved the Equal**  
2 **Distribution of \$1,399,085.43 of Mining Royalties to the eleven Districts of the Tohono**  
3 **O'odham Nation; and**

4 **WHEREAS, the Sells District's portion of this allocation in the amount of \$127,189.58 was not**  
5 **requested in Fiscal Year 2009; and**

6 **WHEREAS, the Sells District has submitted the attached budgets and its justification allocating**  
7 **portions to each of the four communities; \$31,797.39 for Cowlic Community,**  
8 **\$31,797.40 for Ge Oidag Community, \$31,797.39 for North Communities, and**  
9 **\$31,797.40 Sells Community; and**

10 **WHEREAS, the attached budget and it's justification has been reviewed by each of the four**  
11 **communities and the Sells District Council and approved with Resolution #CC-88-09**  
12 **by the Cowlic Community; #SC-04-10 by the Sells Community; #NC-05-2010 by the North**  
13 **Communities, #GO-30-2010 by the Ge Oidag Community, and Sells District Council**  
14 **Resolution #SD-23-10.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
16 **Carry-Over of Fiscal Year 2009 Mining Royalties for the Sells District in the amount of**  
17 **\$127,189.58 to Fiscal Year 2010 with the apportionment of \$31,797.39 for Cowlic**  
18 **Community, \$31,797.40 for Ge Oidag Community, \$31,797.39 for North Communities,**  
19 **and \$31,797.40 for Sells Community.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**  
21 **District Chairperson and any designated official to expend and administer the budget**  
22 **according to its justification, as attached, provided that any**  
23 **modifications/amendments affecting the funds or funding levels of the budget shall**  
24 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
26 **of MARCH, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**  
28 **VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
29 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
31 **Stat. 984).**
