**(Approving the Gu Achi District FY 2010 Budget Amendments for Santa Rosa,
North Santa Rosa and Covered Wells Communities)**

RESOLUTION NO. 10-089

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on March 11, 2010 to address**
2 **issues pertaining to the Nation; and**

3 **WHEREAS, on February 12, 2010, at a regularly scheduled meeting, the Gu Achi District Council**
4 **did approve budget amendments for Santa Rosa (*Amendment #1, Resolution 2010-***
5 ***147*); North Santa Rosa (*Amendment #1, Resolution #0210-143*), and Covered Wells**
6 **(*Amendment #1, Resolution #0210-145*) Communities as attached hereto; and**

7 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review**
8 **the communities' budget amendments submitted by the Gu Achi District and**
9 **recommend for approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
11 **approve the Gu Achi District FY 2010 Budget Amendments for Santa Rosa**
12 **(*Amendment#1*), North Santa Rosa (*Amendment #1*), and Covered Wells (*Amendment***
13 ***#1*) Communities as attached hereto.**

14 **BE IT FURTHER RESOLVED that the amendment does not affect the overall portion of the Gaming**
15 **Distribution of \$1,863,072.77 to the Gu Achi District.**

16 **BE IT FURTHER RESOLVED that any amendments affecting the funds or funding levels of the**
17 **budget shall be approved by the Tohono O'odham Legislative Council.**

18 **BE IT FINALLY RESOLVED that this resolution will be executed in an expedient manner.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
20 **of MARCH, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**
22 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**
