

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Creation of a New Budget for Coldfields Community Utilizing Mining Royalties)**

RESOLUTION NO. 10-090

1 **WHEREAS, at a regular scheduled session of the Tohono O'odham Legislative Council, held on**
2 **March 11, 2010; and**

3 **WHEREAS, Baboquivari District Representatives presented a request to create a new budget, for**
4 **Coldfields Community, utilizing mining royalties, per Baboquivari District Resolution**
5 **09-B-163; and**

6 **WHEREAS, the new budget would create two line items, 727.32 Building Materials, in the amount**
7 **of \$8,870.69 and 810.32 Professional Services in the amount of \$8,870.68, for a total**
8 **amount of \$17,741.37; and**

9 **WHEREAS, this new budget would not affect Coldfields Community's original FY 2010 budget**
10 **amount of \$186,307.28, but would increase the overall Baboquivari District's FY 2010**
11 **current budget amount of \$1,898,555.51 to \$1,916,296.88.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
13 **Coldfields Community's new budget creation to utilize mining royalties in the amount**
14 **of \$17,741.37 and utilizing the two line items of 727.32 Building Materials in the**
15 **amount of \$8,870.69 and 810.32 Professional Services in the amount of \$8,870.68.**

16 **BE IT FURTHER RESOLVED that this new budget creation will not affect the original FY 2010 budget**
17 **for Coldfields Community and will increase the overall FY 2010 budget for Baboquivari**
18 **District of \$1,898,555.51 to \$1,916,296.88.**

19 **BE IT FINALLY RESOLVED that any modifications, amendments or changes in the justifications**
20 **shall be reviewed and approved by the Budget and Finance Committee and the Tohono**
21 **O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
23 **of MARCH, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
25 **VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
