

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Amendment #1 for Fresnal Canyon Community FY 2010 Budget)

RESOLUTION NO. 10-091

1 **WHEREAS, at a regular scheduled session of the Tohono O'odham Legislative Council, held on**
2 **March 11, 2010; and**

3 **WHEREAS, Baboquivari District Representatives presented Fresnal Canyon Community's Budget**
4 **Amendment #1 to their FY 2010 budget; and**

5 **WHEREAS, the Budget Amendment#1 would utilize Mining Royalties in the amount of \$17,741.37,**
6 **per Baboquivari District Resolution #09-B-163; and**

7 **WHEREAS, the Budget Amendment #1 would also decrease line item 750.32 Major Capital**
8 **Equipment by \$6,660.00 to increase line items 612.32 Occasional Appointment by**
9 **\$6,000.00 and 620.32 Fringe Benefits by \$660.00; and**

10 **WHEREAS, the Budget Amendment #1, utilizing Mining Royalties of \$17,741.37, would increase**
11 **line items 727.32 Building Supplies by \$10,000.00 and 810.32 Professional Services by**
12 **\$7,741.37; and**

13 **WHEREAS, this Budget Amendment#1 will increase Fresnal Canyon Community's FY 2010 original**
14 **budget of \$186,307.28 to \$204,048.65 and increase the overall Baboquivari District's**
15 **FY 2010 current budget of \$1,916,296.88 to \$1,934,038.25.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
17 **Fresnal Canyon Community's FY 2010 original budget to amend \$17,741.37 of Mining**
18 **Royalties to line items 727.32 Building Supplies increasing by \$10,000.00 and 810.32**
19 **Professional Services increasing by \$7,741.37 and also decreasing line item 750.32**
20 **Major Capital Equipment by \$6,660.00 to increase line items 612.32 Occasional**
21 **Appointment by \$6,000.00 and 620.32 Fringe Benefits by \$660.00.**

22 **BE IT FURTHER RESOLVED that the Budget Amendment #1 will increase Fresnal Canyon**
23 **Community's 2010 original budget of \$186,307.28 to \$204,048.65 and the overall**
24 **Baboquivari District's FY 2010 current budget of \$1,916,296.88 to \$1,934,038.25.**

25 **BE IT FINALLY RESOLVED that any modifications, amendments or changes in the justifications**
26 **shall be reviewed and approved by the Budget and Finance Committee and the Tohono**
27 **O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
29 **of MARCH, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
31 **VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
32 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**
