

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving First Renewal of the FY 2010 Lobbying Contract with Patton Boggs LLP)

RESOLUTION NO. 10-095

1 **WHEREAS, the Legislative Council is vested with the power to “consult with the Congress of the**
2 **United States and appropriate federal agencies regarding federal activities that affect**
3 **the Tohono O’odham Nation and all federal appropriation estimates and projects for**
4 **the benefit of the Tohono O’odham Nation before such estimates and projects are**
5 **submitted to Congress and other federal agencies” (Constitution of the Tohono**
6 **O’odham Nation, Article VI, Section 1(j)); and**

7 **WHEREAS, the Legislative Council is further vested with the power to “employ legal counsel for**
8 **the protection and advancement of the rights of the Tohono O’odham Nation”**
9 **(Constitution of the Tohono O’odham Nation, Article VI, Section 2(a)); and**

10 **WHEREAS, it is in the Nation’s interest to employ a lobbyist in Washington, D.C. to effectively**
11 **consult with the Congress and federal agencies; provide advice regarding federal**
12 **appropriations, legislation, and programs; and, when authorized, act as a liaison**
13 **between the Nation and the United States; and**

14 **WHEREAS, a Federal Lobbying Contract, including a FY 2010 Billing Rates Schedule and Retainer**
15 **Letter dated September 30, 2009 (collectively, “Lobbying Contract”), was negotiated**
16 **with Patton Boggs LLP (the “Attorneys”) in September 2009; and**

17 **WHEREAS, the Nation’s Lobbying Contract with Patton Boggs LLP expires on March 31, 2010 with**
18 **an option to extend the term; and**

19 **WHEREAS, the firm of Patton Boggs LLP is qualified to provide advice and representation as the**
20 **Nation’s lobbyist; and**

21 **WHEREAS, a “First Renewal of the Lobbying Contract with Patton Boggs LLP” (“First Renewal”) has**
22 **been negotiated with Patton Boggs LLP (“the Attorneys”) which extends the term of the**
23 **Lobbying Contract to September 30, 2010 and appropriates an additional \$150,000.00**
24 **for a total of \$300,000.00 for the FY 2010 Lobbying Contract; and**

25 **WHEREAS, the First Renewal has been reviewed by the Legislative Appropriations, Domestic**
26 **Affairs, and Budget and Finance Committees.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council hereby:**

- 28 **1. Approves the attached First Renewal in the total amount of \$300,000.00 with the**
29 **Attorneys in substantially the form attached hereto for the period commencing on**
30 **October 1, 2009 and ending on September 30, 2010; provided that the First Renewal**
31 **shall be funded from the FY 2010 Executive Branch Administration Lobby Budget,**
32 **Account No. 01-3002, 811-Lobby.**




