3	WHEREAS, the Judicial Branch has an approved FY 2010 Budget in the amount of \$5,732,940.10,
4	which includes employee salaries and other compensation in the amount of

	\$3,754,995.08 and fringe benefits at 34% in the amount of \$1,276,698.33; and
6	WHEREAS, the Tohono O'odham Judicial Branch has submitted the FY 2010 Judicial Budget
7	Amendment #01 for salary adjustment for one (1) current Judge position to match the
8	salaries of the other Judge positions; and
9	$WHEREAS,\ the cost of the proposed FY 2010 Tohono O'odham Judicial Branch Budget Amendment$
10	#01 for the salary adjustment cost at \$139.52 and fringe benefits cost at \$47.44; and
11	WHEREAS, the FY 2010 Judicial Budget has a salary savings of \$117,044.46 and fringe benefits
12	savings of \$39,795.12, the proposed FY 2010 Judicial Budget Amendment #01 does not
13	require any increases in the Salaries or Fringe Benefits line items due to the existing
14	savings in these line items; and
15	WHEREAS, the Judiciary Committee and the Budget and Finance Committee of the Legislative
16	Council of the Tohono O'odham Nation have reviewed this budget.
17	NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation
18	approves the FY 2010 Judicial Branch Budget Amendment #01 submitted by the
19	Judicial Branch as attached.
20	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
21	Chief Judge and any designated official to expend and administer the FY 2010 Judicial
22	Branch Budget Amendment #01 as attached, provided that any amendments affecting
23	the funds or funding level shall be submitted for further prior approval by the Tohono
24	O'odham Legislative Council.
