

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Setting April 16, 2010 at 9:00 a.m. Special Session for the Tohono O'odham Ki:Ki Association to present a Quarterly Update)

LEGISLATIVE ORDER NO. 10-099

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to  
2 regulate all meetings of the Tohono O'odham Council, standing committees, boards  
3 and special committees." (Constitution of the Tohono O'odham Nation, Article VI,  
4 Section 1(a)); and

5 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with  
6 the authority to "by majority vote, call for a special session" (Legislative Rules of the  
7 Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 WHEREAS, since the recent changes in management, issues have been raised in employment  
9 actions; and

10 WHEREAS, the Legislative Council Housing Committee has requested that a special session be set  
11 for April 16, 2010 at 9:00 a.m. for the Tohono O'odham Ki:Ki Association to present a  
12 quarterly update.

13 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a  
14 Special Session for April 16, 2010 at 9:00 a.m. for the Tohono O'odham Ki:Ki Association  
15 to present a quarterly update.

16 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> day of  
17 MARCH, 2010 at a meeting at which a quorum was present with a vote of 2,480.45 FOR; 115.05  
18 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
19 Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
20 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
22 Stat. 984).
