6		Nation ("Gaming Ordinance") was subsequently amended to authorize per capita
7		distribution payments in accordance with the Initiative (Legislative Council
8		Resolution No. 97-303); and
9	WHEREAS,	the Fourth Per Capita Revenue Allocation Plan ("Revenue Allocation Plan") which
10		authorizes the fourth per capita payment to all eligible Tohono O'odham members,
11		was adopted by the Tohono O'odham Legislative Council, Resolution No. 09-164; and
12	WHEREAS,	on June 15, 2009, the Department of the Interior approved the Revenue Allocation
13		Plan; and
14	WHEREAS,	in accordance with the Revenue Allocation Plan, the Tohono O'odham Membership
15		Services presented the Master List for eligible Tohono O'odham Minor Members for
16		the Fourth Per Capita Distribution and established the number of eligible minor
17		members at 8,664 members pursuant to Resolution #09-429; and

26	WHEREAS,	the disbursement of per capita payments to each eligible Tohono O'odham member
27		is contingent upon verification of membership and further certification by the
28		Tohono O'odham Legislative Council.
