

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Contract between the Tohono O'odham Nation and Sutphen
Corporation for the Purchase of an Aerial Ladder Truck)**

RESOLUTION NO. 10-112

1 WHEREAS, the Tohono O'odham Nation Department of Public Safety Fire Department has
2 deemed it critical and necessary to increase Fire Protection services to the Tohono
3 O'odham Nation, particularly the Desert Diamond Casino/Hotel; and

4 WHEREAS, the Tohono O'odham Legislative Council has appropriated funding for the purchase
5 of an aerial ladder truck in the Fire Department's Fiscal Year 2010 budget; and

6 WHEREAS, the Sutphen Corporation has been selected to build an aerial ladder truck for the
7 Tohono O'odham Nation through a competitive bid process.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
9 purchase of an aerial ladder truck in accordance with the terms of the contract and
10 budget attached hereto.

11 BE IT FURTHER RESOLVED that Tohono O'odham Legislative Council hereby authorizes the
12 Chairman of the Nation to execute the attached contract on behalf of the Tohono
13 O'odham Nation.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day
15 of APRIL, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-
16 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article
17 VI, Section 1 (c)(1)(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the
18 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
20 18, 1934 (48 Stat. 984).
