

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Holding April 9, 2010 Legislative Council Session at Schuk Toak Farm)**

LEGISLATIVE ORDER NO. 10-114

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**
4 **Section 1(a)); and**

5 **WHEREAS, Article I, Section 2.C. of the Legislative Rules of the Tohono O'odham Legislative**
6 **Council, as amended, provides that "[a]ll Legislative Council sessions shall be held at**
7 **the Tohono O'odham Legislative Council chambers located in Sells, Tohono O'odham**
8 **Nation, with the following exceptions. . . . [a] majority of all the legislative**
9 **representatives may vote to hold a session in some location other than the chambers**
10 **located at Sells."; and**

11 **WHEREAS, the Legislative Agricultural Committee has recommended that the Legislative Council**
12 **tour the Schuk Toak Farm during the April 9, 2010 general session.**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that the April 9,**
14 **2010 general session shall be held at Schuk Toak Farm and roll call shall be conducted**
15 **at 9:00 a.m.**

16 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 05TH day of**
17 **APRIL, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
18 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of**
19 **Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
21 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
