6	WHEREAS, it is in the Nation's interest to appoint an expert consultant to evaluate the Nation's						
7	claims, to estimate the damages that could be awarded in a trial of the case, and						
8	potentially to serve as a trial witness; and						
9	WHEREAS, the Tohono O'odham Legislative Council has interviewed three consulting firms with						
10	the expertise and background suitable for work on the Nation's cases, and has made						
11	a selection.						
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has selected						
13	Rocky Hill Advisors, Inc., as the Nation's expert consultant on the pending tribal trust						
14	cases.						
15	BE IT FINALLY RESOLVED that the Attorney General will negotiate a contract with this consulting						
16	firm and will present a contract to the Legislative Council for approval.
