3	WHEREAS, the Environmental Protection Office found a need to move monies within the FY 10
4	budget; and
5	WHEREAS, there is a need to add 655 Lodging line item for travel; and
6	WHEREAS, the Environmental Protection Office has made adjustments to the FY 10 budget by
7	increasing line item 650 Tuition & Registration; decreasing line items 660 Travel
8	Expense and 721 Supplies – Other; and adding in new line item 655 Lodging.
9	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts
10	and approves the budget amendment #2, moving funds within the budget and adding
11	1 new line item to the current budget in the following manner:
12	1. Increasing Line Item 650 Tuition & Registration \$800.00
13	2. Adding Line item 655 Lodging \$2,500.00
14	3. Decreasing Line item 660 Travel Expense \$1,500.00
15	4. Decreasing Line item 721 Supplies-Other \$1,800.00
16	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that Tohono O'odham
17	Nation's Officials, to wit: the Chairman, Vice-Chairman and any designated official are
18	hereby authorized to negotiate and execute the tribal funding, provided however, that
19	any amendments affecting the funding or funding level of the tribal fund shall be
20	submitted for further prior approval.
