

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Authorizing Budget Amendment 1 to the FY 2010 Agriculture Extension (BIA))**

**RESOLUTION NO. 10-120**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 09-591 approved a total FY**  
2 **2010 budget for Agricultural Extension (BIA) in the amount of \$144,874.51; and**  
3 **WHEREAS, the Nation's Grants and Contracts identified the amount \$163,771.38 in FY 2009 carry**  
4 **forward funds from the FY2009 BIA funding; and**  
5 **WHEREAS, the Agricultural Extension is requesting that the FY2009 carry forward funds in the**  
6 **amount of \$53,241.72 and indirect cost charge of \$2,562.27 for a total of \$55,803.99**  
7 **be added to the FY2010 Agricultural Extension (BIA) Budget 10-1510, for a total of**  
8 **\$200,678.50; and**  
9 **WHEREAS, the remaining funds of \$110,529.76 from the \$163,771.38 be added to the Range**  
10 **Conservation and Management Program Budget; and**  
11 **WHEREAS, the additional funds for the Agricultural Extension (BIA) will now include additional**  
12 **line items 650 Tuition and Registration, 655 Lodging, 660 Travel expense and 750**  
13 **Major Capital Equipment; and**  
14 **WHEREAS, the Agricultural Extension ( BIA) budget 10-1510 has been reviewed by the Legislative**  
15 **Agricultural Committee and the Budget and Finance Committee.**  
16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council hereby approves**  
17 **Amendment #1 to the FY 2010 Agricultural Extension (BIA) Account #10-1510 to add**  
18 **line items 650 Tuition and Registration, 655 Lodging, 660 Travel Expense, 750 Capital**  
19 **Equipment, and increase program line items in the total amount of \$53,241.72 with the**  
20 **addition of FY2009 Bureau of Indian Affairs carry forward funds plus indirect cost**  
21 **charge, in the amount of \$2,562.27 to Agricultural Extension (BIA) FY 2010 budget**  
22 **Account #10-1510, which will increase the current budget of \$144,874.51 to a new total**  
23 **budget of \$200,678. 50 in accordance with the budget attached hereto.**  
24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Official, to wit; the Chairman, Vice-Chairman and any designated official are**  
26 **authorized to administer the FY 2010 Agricultural Extension (BIA) Budget, provided**  
27 **however, that any amendments affecting the funds or funding levels of the budget**  
28 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
