**RESOLUTION NO. 10-121**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2010 Range Conservation**  
2 **and Management Program BIA Budget 10-1513 through Resolution 09-271, in the**  
3 **amount of \$712,802.36; and**

4 **WHEREAS, the Nation's Grants and Contracts Office has identified \$163,771.48 carry forward**  
5 **funds from the FY2009 BIA funding; and**

6 **WHEREAS, the Range Conservation and Management Program is requesting that the FY2009 carry**  
7 **forward funds in the amount of \$110,529.76 and indirect cost charge (Contract**  
8 **Support) of \$13,647.51 for a total of \$124,177.27 be added to the FY2010 Range**  
9 **Conservation and Management Program BIA Budget 10-1513 for a total budget of**  
10 **\$836,979.63; and**

11 **WHEREAS, the remaining funds of \$53,241.72 from the \$163,771.48 be added to the Agricultural**  
12 **Extension FY2010 Budget; and**

13 **WHEREAS, the Range Conservation and Management Program is also requesting that Line Item**  
14 **750 Major Capital Equipment be added to the FY2010 Range Conservation and**  
15 **Management Program BIA Budget 10-1513; and**

16 **WHEREAS, Amendment 1 to the FY2010 Range Conservation and Management Program BIA**  
17 **Budget 10-1513 has been reviewed by the Legislative Agricultural Committee and the**  
18 **Budget and Finance Committee.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
20 **Amendment 1 in accordance with the budget attached hereto:**

21 **1. To add the FY2009 Bureau of Indian Affairs carry forward funds in the amount of**  
22 **\$110,529.76 and indirect cost charge of \$13,647.51 (Contract Support) for a total of**  
23 **\$124,177.27 be added to the FY2010 Range Conservation and Management**  
24 **Program BIA Budget 10-1513 which increases the current budget of \$712,802.36 to**  
25 **a new total budget of \$836,979.63.**

26 **2. To add Line Item 750 - Major Capital Equipment to purchase 1 Program Vehicle.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**  
28 **the Chairperson and any designated official to expend and administer the budget, as**

7 Article VI, of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham  
8 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
9 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
